Loss-making state-owned telecom service providers, Bharat Sanchar Nigam (BSNL) and MTNL will not be privatised; instead they will be turned around, telecom minister Ravi Shankar Prasad has said. For the private sector players, the minister's message is that he's willing to take a re-look at the merger and acquisition guidelines finalised by the UPA government, if they feel that it is not workable. Also that sufficient spectrum to operators and its optimum utilisation by them will be ensured by him.

In a wide-ranging interview with FE, Prasad, who also holds the law portfolio, acknowledged that there were serious problems with the two PSUs. He also alleged that the previous government had ruined them and was responsible for their current plight. "BSNL and MTNL were not provided the requisite infrastructure support for 4-5 years by the previous government. There were forces interested that they do not do well and they succeeded," Prasad said.

Asked how does he plan to turn around the units that have been posting losses for the last 4-5 years and having a miniscule market share of 11%, Prasad said that he has experience in turning around loss-making PSUs and has done so with Coal India when he was coal minister during the Vajpayee government's regime. "When I was a coal minister in the Vajpayee government, CIL had a net loss of around R1,400 crore. Within one-and-a-half years, I turned around the company and it posted a net profit of around R1,500 crore," Prasad said. The minister declined to give a time-frame for turning around BSNL and MTNL but said that he was closely monitoring them. Though he did not share his strategy for turning them around, he said that a merger between the two was being contemplated.

Prasad, who is overseeing the Digital India project of Prime Minister Narendra Modi, acknowledged that average spectrum holding with domestic operators was small compared to global averages. He also agreed that unless optimal spectrum was not provided to the operators, programmes like e-governance, e-health and e-education would not succeed.

He said that he's directed his officials to work out the final guidelines for spectrum trading and sharing by the year end. Also spectrum harmonisation is being worked out with the defence ministry so that more 2G and 3G spectrum is released for commercial services. "Sharing and trading guidelines would be in place by the year-end and so would be the case with spectrum harmonisation.

# TRAI makes it mandatory for the Telecos to send hardcopy of postpaid bills to the consumers without any extra charges

TRAI has issued a notice to all the telecom operators saying that it is made mandatory for them to print the postpaid bills and send it to their registered address. The circular also mentions that the Telecos are not supposed to charge extra for the billing services. This move comes after it was brought to the notice of the Authority that some of the service providers were not providing hard copy of the bill to the postpaid subscribers.

In this connection, following directions have been issued by TRAI, for the Service Providers:

i) to provide hard copy / printed copy of the bill to all post-paid subscribers, free of cost for connections provided under Basic Services (other than ISDN) and Cellular Mobile Telecom. Service. However, if any customer opts for receipt of the bill through e-mail, instead of hard copy, the same may be supplied after obtaining explicit consent from the consumer. In all other cases, the Service Provider must ensure that the bills are generated and delivered to the consumers in printed form free of cost.

ii) to provide itemized bill in respect of long distance calls, free of cost to consumers, on request.

iii) providing itemized bills for local calls and SMS remains under forbearance.

This order seems to be an outdated move as the entire world is moving towards a paper less greener environment. On the contrary it is also true that many consumers have been squabbling over non receival of postpaid bills. TRAI has also asked the Telecos to provide the itemised bill for International call free of cost. We hope that in the future TRAI would come up with a more creative move that will resolve the issue and also pave way for a greener environment.

Rural India to get Wi-Fi connected in two years: Ravi Shankar Prasad BHOPAL: Union minister for communications and information technology Ravi Shankar Prasad unfolded Prime Minister Narendra Modi's 'digital India' dream, here on Monday afternoon. Prasad claimed that to bridge the gap between digital India and IT deprived rural areas, the Union government targets joining 50,000 villages with broadband connectivity by the end of this fiscal year.

By 2015-16, another one lakh hamlets will be linked and yet another one lakh rural habitations by 2016-17. "This is our Bharat Jodo Abhiyan(Unite India Movement) to take the Wi-Fi connection to our villages," Prasad who was in Madhya Pradesh to lay the foundation stone of the country's first two electronic manufacturing clusters - one in Jabalpur and another in Bhopal - on Monday.

He argued that the Modi government will soon bring a new BPO policy to include the youth of small towns in business process outsourcing jobs. Prasad justified that in IT hubs like Hyderabad, Bangalore and Chennai there are youths from small towns of Madhya Pradesh and Bihar who work in BPO offices. The new BPO policy will ensure that this young crowd does not have to leave their states in search of employment.

"The calculation is simple. It is IT (India's talent) + IT (information technology) = IT (India tomorrow)," the Union minister said. Prasad explained that 90 crore mobile phones are being used in the country along with the SIM cards and smart cards and yet none of it is manufactured here. "We import \$100 billion of electronics which is to soon become \$400 billion and the country would pay more than we do for petrol. This is why a meeting of all IT secretaries of states was called and letters reached the chief ministers," he explained.

Prasad announced that Rs 38 crores would be given by the Centre to set-up the two manufacturing clusters. In addition, any company that starts producing electronics and applies to the Centre will get a support with 20 per cent of the installation costs. He invited investors to manufacture solar lamps, computers, software, LED lights and other electronics equipment for the defence sector.

"The Modi government has agreed to 49% foreign direct investment in defence manufacturing. And 60 per cent of these defence equipment are essentially electronic goods. We have to start manufacturing electronics for our defence machinery. The summary of it all is to Make in India - invest and manufacture here," he added.
